



Bahrain Government Open Data License (Version 1.0 – 20 May 2025)

1. Scope of the License

This license applies to all datasets officially published by the Government of Bahrain through its open data portal (www.data.gov.bh) or any other government website that published government open data.

2. Acceptance of License Terms of Use

By using the datasets under this license, you shall be deemed to have accepted to be legally bound by these Terms of Use. If you do not agree to these Terms of Use, do not use any datasets published by the Government of Bahrain.

These Terms of Use may change from time to time without notice. Please check the Terms of Use whenever you access or download the datasets for use.

3. Terms and Conditions of Use

3.1 This license allows you a royalty-free, non-exclusive use of the datasets for the following purposes:

- (a) sharing, copying, distributing or transmitting the datasets.
- (b) adapting the datasets to suit your needs.
- (c) using the datasets for applications that you develop or integrate with.
- (d) commercializing the applications that you develop using the datasets.

3.2 Users of open data are expected to follow to ethical principles in their use of the data, including respecting privacy, avoiding discrimination, and ensuring transparency.

3.3 You must:

- (a) Include attribution by clearly stating in your applications, research, articles, or websites containing the datasets the source of the datasets and the date the datasets were extracted. If you are using data from several providers and listing multiple attributions is not practical in your product, service or application, you must include a URL or hyperlink to a page that contains the required attribution statements.
- (b) Clearly indicate that any analysis or transformation of data is made by you and shall not be attributed to the iGA or the concerned government entity.



- (c) Clearly state in your applications, research, articles, websites, products, services containing the datasets: "Datasets provided by the <entity name> via www.data.gov.bh are governed by the Bahrain Government Open Data License available at www.data.gov.bh/en/xxxxxx. To the fullest extent permitted by law, the government is not liable for any damage or loss of any kind caused directly or indirectly by the use or availability of the datasets or any derived analyses or applications.”.
- (d) Include the same requirements stated in paragraphs a, b and c in any sub licenses that you grant, require your sub-licensees to do the same.
- (e) Cease to use the datasets and remove them from your applications or websites upon the request of the iGA or the concerned government entity in the event that the datasets are no longer provided on www.data.gov.bh or of a breach of any of the license Terms of Use.

3.4 You must not use the data for purposes deemed inappropriate and/or misleading to the public. Such instances include but are not limited to:

- (a) presenting the datasets in a misleading or incorrect manner, or misrepresenting the data; or
- (b) using the data to promote or support any illegal activities.

3.5 The breach of any of these Terms of Use shall result in the cancellation of the license to use the datasets granted to you under clause 3.2. These Terms of Use (except for clause 3.2) shall survive the cancellation of the license under 3.2.

4. Exemptions (What is Not Covered)

- Personal data that could identify individuals, in accordance with Personal Data Protection Law No. 30 of 2018.

- Data that is classified, confidential, or subject to other restrictions, in accordance with the Protection of State Information and Documents Law No. 16 of 2014 and its amendment by virtue of Legislative Decree No. 14 of 2023.

- The data is provided "as is", without warranties of any kind.

- The Government of Bahrain does not guarantee the accuracy, completeness, or timeliness of the data.

- The government is not liable for any damages or losses resulting from the use of the data.



6. Governing Law

These Terms of Use shall be governed by and construed in accordance with the laws of the Kingdom of Bahrain. You irrevocably agree for the exclusive benefit of the iGA and concerned government entities that the Bahrain courts shall have exclusive jurisdiction in relation to any dispute arising from or relating to these Terms of Use, and for such purposes irrevocably submit to the jurisdiction of the Bahrain courts.
